A realistic expectation of time commitments necessary to fulfil the minimum requirements of a trustee are:

Minimum time requirements approx. 8 days pa (meetings take place both online and in person)

- Planning days x2 full days
- Board Meetings x4 half day
- Committee Meetings x4 half day

Our current governance structure includes 2 committees who report directly into the Board, they are: Governance, Finance & Risk Committee (GFR), and People & Performance Committee (P&P). It is expected that trustees will sit as a member on one of these committees.

To deliver against these duties, Active Cheshire's trustees need to be able to identify the critical issues - the charity's objects and plans, its solvency, its resilience and quality of governance - and to be able to review these at regular intervals.
