

# Safeguarding Strategy 2022 – 2025



Active Cheshire CONNECTED, our strategic vision to 2040, highlights the significant role we must play as systems leaders in the physical activity system and in safeguarding children and adults at risk. We take our safeguarding responsibility seriously at all levels of our organisation and will use our platform and relationships to create a safer environment as participation in physical activity, movement and sport grows.

Active Cheshire's Safeguarding Policies are annually reviewed by our Board of Trustees, under the guidance and stewardship of our Safeguarding Board Champion. We value our partnership with the NSPCC and Child Protection in Sport Unit (CPSU) and welcome the support and knowledge of local partners in further developing our understanding.

CONNECTED states our intention to provide an interconnectivity between community providers, strategic partners (from governing bodies to 'unorganised' providers) and Statutory Safeguarding Organisations. We will:

#### Know - Grow - Show - Shape - Share

KNOW –	To gain understanding of key safeguarding issues across sport and physical activity in Cheshire & Warrington through effective sharing of safeguarding data and insight between NGB/non-NGB organisations and statutory organisations.				
GROW –	To widen the network of people we are talking to about safeguarding issues, backed up by data and insight that is relevant to our local physical activity system.				
SHOW –	Demonstrate our commitment to safeguarding as an organisation by what we do internally and how we advocate for safeguarding within the physical activity system.				
SHAPE –	Be part of how the system views and responds to safeguarding. Drive a system approach that is proactive rather than reactive. Ensuring that all safeguarding alerts shape how safeguarding in sport and physical activity locally is approached.				
SHARE –	Provide platforms and take opportunities to share data and insight relating to local thematic safeguarding themes around sport and physical activity. Ensuring organisations are connected, and good practice is talked about. Creating a safe space for learning to take place.

The key to the success for our strategy is embracing our learning culture, utilising lived experiences, combining best practice with research from partners and articulately detailing the impact our strategy has upon the lives of children and adults at risk in Cheshire and Warrington. The details of this can be found in our Implementation and Action Plan (page 4-7).

For clarity, our role within the Physical Activity is defined as a connector and influencer. We will work with partners to shape their policies and share best practice from across the system. Our role is not to supersede safeguarding policies and procedures already in place within organisations or National

Governing Bodies. Should we receive any safeguarding concerns directly to Active Cheshire, we will sign-post these to the appropriate NGB where possible.

#### Our journey so far

In our 21-22 annual safeguarding review, we identified that the next year would be focused on understanding our role as a system leader, linked to our Sport England investment, and how this would shape our role within safeguarding. As we repositioned, we knew that we need to approach things differently to maintain impact, with the question of 'so what?' guiding our decisions.

After time to reflect and better understand the local picture, our position will be to drive a systematic approach with collective ownership of safeguarding across the local physical activity system. It will be flexible, thematic, proactive, meaningful, and ongoing, with the continued focus of safeguarding becoming the 'Golden Thread' not just internally but within the local physical activity system as a whole. Additionally, understanding impact around safeguarding will be embedded to ensure the overarching 'so what?' question can be answered.

#### Why we need to act now

In recent years, high profile reports have been released cataloguing the many and repeated failings of sports governing bodies in safeguarding, The Sheldon Review (2021) into historical child sex abuse in Association Football found that survivors were 'let down by the game, the authorities and society as a whole, and made 13 recommendations for improvement. The Whyte Review (2022) into mistreatment of gymnasts found a 'culture of silence' which prevented athletes from speaking up under their authoritarian regimes.

In 2017, Dame Tanni Grey-Thompson conducted a Duty of Care review which has led to a legislative amendment in September 2022, closing a legal loophole in the law that means some adults who hold a position of power over a young person aged 16 or 17 (including sports coaches) can legally have sex with them.

Engagement with partners identifies key themes linked to safeguarding within physical activity and sport, across Cheshire and Warrington. Whilst some of these are well talked about, some fall under the radar. We want to ensure that nothing goes unknown, enabling both strategic and community organisations to protect the children and young people and adults at risk they work with and prevent abuse and neglect.

#### **National Alignment**

Active Cheshire is committed to working in partnership with the NSPCC, CPSU and Ann Craft Trust. We will work systemically to embed safeguarding as the 'golden thread' in sport and physical activity across Cheshire and Warrington, ensuring that every child and adult at risk can be active in a safe and supportive environment. In doing so, we will also support our partners to realise their strategic goals. Synergy can be seen between our strategy and 'Preventing Child Abuse Together'. The NSPCC will 'Do', Enable' and 'Influence'. Active Cheshire will apply 'Know, Grow, Show, Shape and Share'.

We will connect (**Grow**) leaders within our local sport and physical activity system (**Shape**) to enable sharing (**Share**) of data and insight (**Know**), which will influence (**Show**) how we protect children and young people collectively within our communities. With this data and insight comes the empowerment of organisations to take informed, preventative measures.

#### **Understanding Our Impact**

We know that systemic change takes time. Therefore, we will need to measure our impact against shortand long-term impact points.

In the short term, we will drive and begin to shape a system approach to safeguarding for sport and physical activity across Cheshire and Warrington. Safeguarding will sit at the forefront of agendas at the Cheshire and Warrington Physical Activity Leaders Forum and together, through sharing of data and insight, better understanding of safeguarding issues across sport and physical activity settings will be developed. This understanding will be fed into community activities, keeping children, young people and adults at risk safer.

Over time, through the connected nature of our approach, we will see the bigger picture. This will enable us not only to educate at a community level, but to inform statutory bodies of key themes, ensuring that no common occurrences of safeguarding issues go unshared to the wider network.

In the long-term, impact will come in the sport and physical activity system being able to collectively capture and feed into the bigger picture. This will allow for increased awareness of safeguarding risks, as well as the ability to influence training and approaches to safeguarding in sport and physical activity, specific to our local area. We will see safeguarding embedded as the 'golden thread' not just internally to Active Cheshire but across the sport and physical activity system.
